1. General information**a) Performance Review**

The Economic Entity and the Bank registered a profit before zakat and tax of RM0.2m and RM0.8m respectively for the six months period ended 30 June 2011.

The Economic Entity and the Bank's gross financing and advances stood at RM727.3m whilst total Deposit at RM1, 599.9m.

b) Business Plan and outlook for 2H2011

The world economy is still surrounded by risks. The Middle East and North Africa crisis, the European debt problem, Japan's catastrophes and the end of US quantitative easing poses uncertainty and clouded the speed of recovery. Developing Asia however remains robust with strong domestic demand and rising inflationary pressures.

In Malaysia, the 1Q11 GDP growth recorded a healthy 4.6% year-on-year, with private (6.7%) and public (6.1%) consumption offsetting a larger drag from net exports (-24.2%). By sector, services (5.9%) and manufacturing (5.4%) were the main growth drivers. Economic growth momentum will probably moderate in 2Q11 on supply disruptions from the Japan disaster, pullback in commodity prices, rising cost-push inflation, and higher debt servicing burden. Rebound is expected in 2H11 due to the reconstruction of Japan and implementation of ETP projects.

In line with its vision to empower business with Islamic banking values, the Bank will continue to leverage on its Middle East connection to create and bridge business opportunities between Malaysia and the Middle East as well as regionally including Indonesia and Brunei, especially for funding GLCs, in the sectors of oil & gas, shipping, aviation, infrastructure as well as real estate.

The Bank is also actively developing new products as well as risk mitigating strategies to suit varied business requirements, customer's expectations and the different risk profiles.

Based on the positive outlook, the Bank is poised to face the challenges ahead in 2H2011 to chart further growth in its funded assets and hence contribute towards improvement in its profitability.
